Journal dedicates issue to world's young workers

The International Journal of Occupational and Environmental Health has dedicated its current issue (Volume 16, Number 2) to "Child Labor and Protecting Young Workers Around the World." Guest editors are Mary Miller, Washington State Department of Labor and Industries, and Sharon Cooper and Eva Shipp, University of Texas Health Science Center at Houston School of Public Health, San Antonio Regional Campus.

According to the International Labour Organization, at least 126 million children are performing hazardous work. Miller writes: "This issue presents research on child and adolescent labor around the world, focusing on studies that evaluate health effects from exposures at work; programmatic interventions to reduce work exposures or limit hazardous work activities; and policy mechanisms to reduce the negative health impacts from working too many hours, night hours, or in settings that are too dangerous and inappropriate for youth under age 18."

The National Children's Center has available the popular Agritourism Health and Safety Guidelines for Children, as well as two supplemental publications: the Policies and Procedures Guide and the Worksite Guide (<http://www.marshfieldclinic.org/agritourism>). who host children and groups. The guides are useful in reviewing health and safety considerations already implemented on agritourism operations, and can assist in identifying deficiencies so that remedial action can be taken.

NAGCAT: To assist parents and others in assigning age-appropriate tasks for children ages 7-16 there are the North American Guidelines for Children's Agricultural Tasks (NAGCAT). The guidelines (www.nagcat.org) are based on an understanding of childhood growth and development, agricultural practices, principles of childhood injury, and agricultural and occupational safety. Voluntary use of the guidelines can help parents and others make informed decisions about appropriate tasks for youth.
