



## Emerging Issues Program Frequently Asked Questions (FAQ)

### **General**

Can the project include activities that educate only children/youth?

- No. The project must address/influence parents and adults, not just children.

How can I improve my chances of being funded?

- Have a clear project focused on a new or unresolved childhood agricultural safety or health issue.
- Have the potential to guide future efforts related to child agricultural health and safety.
- Show high potential to address the issue within the funding year.
- Address one or more of the priority areas listed in the Call for Proposals.
- Collaborate with individuals who have expertise in an area where you may be weak (e.g., survey development, evaluation, child development); contact the NCCRAHS or your regional NIOSH Center for Agricultural Safety and Health for suggestions.
  - Include evaluation: how will you demonstrate and track that the desired objectives have been achieved?
- Have reasonable expectations about what you can accomplish in one year.
- Have an external reviewer look over your proposal before submitting it.
- Follow the review criteria listed on the Call for Proposals.

### **Eligibility**

I have been working in child agricultural safety for more than 10 years. Can I apply?

- Yes. Senior/tenured researchers/staff are able to submit an application as Principal Investigator / Project Leader. Junior faculty building their expertise in childhood agricultural health and safety are also encouraged to apply.

May I apply if I am part of a community-based organization or national group not affiliated with a university?

- Yes. National, regional, and local non-profit organizations are encouraged to apply.

If I applied in a previous year and was not funded, can I apply again this year?

- Yes. You may submit a new or substantially revised project if you have previously applied. Resubmissions of previously unfunded projects should address all areas of concern from the last submission.

If I applied and was successful in a previous year, may I be apply again?

- Yes. You may submit a new project proposal. Projects from previously funded investigators must be substantially different from prior funded work.

If I am successful with the project I am proposing, may I apply next year for funds to continue the project?

- No. You must find other sources of funding to continue the project.

### **Application process:**

May I include my (video, podcast, Flickr album, etc.) as an appendix?



- Yes. You may include a link (URL) to any available digital media or site which is relevant. However, reviewers are not required to visit such links in their review process.

May I include our 60 page handbook as an appendix?

- No. The 5 page limit for appendices is firm. Proposals and appendices that exceed page limits will be returned. Consider having longer materials hosted on a website accessible via a link (URL) on the Internet (see note above).

**Institutional requirements:**

Will I have to submit my proposal to an Institutional Review Board (IRB)?

- If your project qualifies as human subjects research, you will need to receive IRB approval for your project. You do not need to submit your project for IRB approval until after you have been notified that your project has been funded. Funds will be released after approval is granted through your institution's IRB.
