Director's Report

On March 14th, I had the opportunity to make a presentation to the Marshfield Clinic Board of Directors. Included was a brief history of the Institute, beginning with its founding in 1958 with Dr. Stefan Epstein as its first President and myself as Executive Director. I had the honor of serving as Co-investigator on our first two projects receiving R01 NIH grants, awarded to Dr. Epstein and Dr. Emanuel. The growth of the Institute was traced over the years, ending with a more detailed description of our research activities in 2016. This included receiving awards for 27 projects totaling \$10.4 million as well as the authoring of 146 publications by members of the Clinic and the research group.

Also reviewed during this presentation was the MCRI strategic plan with the upcoming focus on precision medicine, cancer, clinical and health services research along with the projection that all Centers within the Institute will continue to grow and expand during the next several years. Implementation of the new financial model for FY 2017, which was designed and adopted to provide a more precise method of forecasting revenue and expenses utilizing an allocation methodology, was discussed.

The first two months of calendar 2017 featured a record number of grant proposal submissions. During January and February, 15 grants were submitted, most of which were destined for federal and state agencies. The total requested funding was \$8.6 million.

With this backdrop, it is necessary to recognize what is happening in Washington, DC and voice concern. The president's budget proposes what would amount to a nearly 20% cut to the NIH budget, which would mean that very few new grants would be funded since 75 to 80% of NIH's budget is pre-allocated every year. This would have a profound effect on young investigators in particular. The United States can ill afford such a drastic cut at a time when it is struggling with the effectiveness and efficiency of the healthcare system which needs both fundamental and translational research to survive. The hope is that champions will emerge in the House and Senate to carry the message about the importance of research. At this point it appears that the White House has no such resident champion.

We were saddened this week by the death of a longtime retired staff member Russell Jacobson. Russell joined the research group many years ago and served faithfully for 37 years caring for the animal population. He took his responsibilities very seriously with a 24/7 approach to his work. He was kind and gentle and one of the most faithful individuals I have ever had an opportunity to work with. I had the privilege along with other members of the staff to bid goodbye to Russell at a service in his honor on March 22, 2017.

The presentations and discussions of the conference were impactful and interesting in many ways. Health services research is a broad field, and the work of the HCSRN members reflects that. Aside from the presentation and posters on specific research topics, the plenary sessions were led by representatives of PCORI, AHRQ, NCI, as well as a former member of the Obama healthcare administration. Needless to say, with the current federal environment, their discussions and perspectives were insightful.

I want to thank those from MCRI who were able to attend the conference and provided our strong representation. Also, thank you to those who contribute to the lead role MCRI has in the HCSRN. Be sure to take care of yourself as well. Thank you again for all you do.


IOSH Scientists and Staff Present at the International Association of Dental Research Conference in San Francisco

Dr. Amit Acharya, Dr. Ingrid Glurich, Dr. Katie Overmyer, Dr. Adham Abdelrahim, Neel Shimpi, Harshad Hegde and Annie Steinmetz presented their research from Marshfield Clinic at the 9th Annual meeting of International Association of Dental Research (IADR) General Session & Exhibition in San Francisco, California, on March 22 – 25, 2017. This cutting edge international dental research conference was organized around exciting and diverse themes representing the major scientific topics in current dental, oral and craniofacial research findings from around the world. The conference attracted over 5000 health care and research professionals globally.

Volunteering Plays An Important Role

Part of the MCHS mission is to "Enrich Lives". The Institute does this through compassionate health care and responsible human subject research. This should also involve good stewardship of our communities. With this in mind, the MCRI strategic plan has included as part of its Community Engagement goals the promotion of volunteerism and the celebration of those staff members who currently are engaged in volunteering with local organizations.

To begin our work on this goal, a survey was distributed in February to assess MCRI staff's current level of volunteer activity. While Institute leadership has been aware of some activities such as STEM scouts and Center-initiated food drives, this survey was the first attempt to formally collect data on participation.

209 MCRI staff members received the survey request. Of the 89 respondents, 55 staff members reported volunteering within the last year for a total of more than 2,800 hours. 15 survey participants stated they each had contributed more than 100 hours to local organizations. In its most recent data, the Corporation for National and Community Service (CNCS) reported that the median number of hours contributed by rural Wisconsin residents was 52 hours. MCRI was not too far off from this number at a median of 40 hours.

Wisconsin overall participates at an impressive rate of 35.3% of residents reporting volunteer activities, ranking the state 3rd in the nation. A total of 1.6 million Wisconsin volunteers contributed hours valued at \$4.6 billion. These "donated hours" non-profit and community groups receive are sometimes the difference between whether an organization can accomplish its mission or must discontinue services.

In the coming months, we hope to promote volunteer opportunities and encourage MCRI staff to further participate in these activities. We also look forward to spotlighting volunteers and Centers in celebration of the work they do.
